

**Town of Sherry
Regular Board Monthly Meeting Minutes
January 8, 2019**

The regular Town Board monthly meeting was called to order 6:50 p.m., with Chairman Homb, Supervisor Bean and Supervisor Hetze, Clerk Ewoldt, Deputy Clerk Dimick and Treasurer Haas present.

The minutes from the December Town Board meeting were reviewed and approved with **a motion** by Supervisor Bean, second by Supervisor Hetze. **Motion carried.**

The treasurer's report was reviewed and approved with **a motion** by Supervisor Bean, Second by Supervisor Hetze. **Motion carried.**

County Representative Report: No report

Recycling Center: The Recycling Board is scheduled to meet January 29, 2019. A notice will be posted when the date and agenda are confirmed.

Fairview Cemetery: Nothing new to report.

Spring Primary: There is not a statewide, nor county-wide February primary. There is a Stevens Point School Board primary needed. The Town of Sherry is working with the Stevens Point School Board, County Clerk, Wisconsin Election Commission, and the Village of Milladore to set the Village Office as the polling place for the Spring Primary due to the limited number of Town of Sherry voters in the Stevens Point School District. A cost sharing arrangement between the Town of Sherry and Village of Milladore was discussed. There was a **motion** by Supervisor Bean, second by Supervisor Hetze to pay \$200 as a cost share measure with the Village of Milladore. **Motion carried.**

Roads/Bridges: Road Maintenance: No discussion on roads. The Town Truck has a radiator leak which needs to be fixed.

WTA District Meeting: Members of the Board will attend the March 30th meeting at Stevens Point.

Transfer Funds from Tax Savings to Checking: **There was a motion** to transfer \$325,000 from tax saving to checking by Supervisor Bean, second by Supervisor Hetze. **Motion carried.**

Pay Bills: **There was a motion to pay bills**, by Supervisor Bean, second by Supervisor Hetze. **Motion carried.**

Public Input:

There was a complaint reported about dogs barking in the Sherry Town Proper. Chairman Homb will contact the dog owner again.

There was a question about the closed session at the December meeting.

There was a comment and recommendation made about mud on town roads when spring field work begins.

Suggestion to do a letter to all town residents. Whoever puts the mud on the roads must clean it up. If the town cleans it, the responsible party will be charged. Chairman Homb will decide how to notify residents.
