This will replace the 130 bed jail built in 1955. The dedication of the LaVonne Zenner Memorial Bridge was on 8/3/2022 over U.S. 10 on County Rd A. Wood County Highway Department reports shortage of drivers.

Sherry-Milladore Recycling Center: Eavestroughs were added to building to divert rain from in front of recycling center building.

Fairview Cemetery: Supervisor Bean reports new activity of two monument placements, and two lots staked for upcoming burials: Plot 67, Lot 5; and Plot 81, Lot 4.
