# Town of Sherry Regular Board of Supervisors Monthly Meeting Minutes October 18, 2023

**The regular Town Board** monthly meeting was called to order followed by the Pledge of Allegiance at 7:00 p.m. by Chairman Lang, Supervisor Bean, Supervisor Holtz, Clerk Lobner, and Treasurer Haas present.

**Additions to the Agenda**: Roaming Dogs in Town, Preliminary Budget Planning, Coordination Plan Review and Update, .gov Emails.

**The minutes from** the September 12, 2023, Town Board of Supervisors meeting was reviewed and approved with minor corrections by a **motion** by Supervisor Bean, second by Supervisor Holtz. **Motion carried**.

**The treasurer's report** was reviewed and approved with a **motion** by Supervisor Holtz, second by Supervisor Bean. **Motion carried**.

**Pay Bills:** Bill review completed followed by a **motion** to pay bills by Supervisor Holtz, second by Supervisor Bean. **Motion carried**.

**Transfer Funds from Tax Savings to Checking:** A **motion** by Supervisor Bean, second by Supervisor Holtz to transfer \$30,000 from savings account to checking for monthly expenses. **Motion carried**.

County Representative Report: No report.

**Town Hall LED Lighting Update:** Await arrival of LED lighting fixtures and installation this winter.

Certified Survey Maps: None.

**Rural Mutual Insurance Policy Review**: A **motion** by Supervisor Bean, second by Chairman Lang for Supervisor Holtz to arrange an insurance policy review and update policy as needed. **Motion carried**.

## Storage Shed Update

Supervisor Bean reports construction continues with installation of natural gas line, electrical
wiring, and building heater. Building insulation, overhead and entrance door installation to follow.
Building will be completed prior to winter.

### Roads / Bridges and Road Maintenance:

- Bliven Lane Tabled.
- Road grading will begin after the next rain.
- Supervisor Bean attends the TRIP Pilot Program meetings. AgRIP Pilot Program specifications will be released in 2024.
- Road assessments completed on September 27 with WISLR reporting due December 15.

**Fairview Cemetery:** Supervisor Bean reports a request for Plot 66, Lot 1 transfer within Mancl/Mielke family members received. Surviving family members have agreed by completing their Plot/Lot Designation forms. Supervisor Bean reports a recent burial of ashes without a vault. Fairview Cemetery requires a burial vault for all burials including urns. A letter will be sent to the family to rectify the burial vault situation. Cemetery lot staking is required.

**Recycling Center Update:** Supervisor Holtz reports the Recycling Board will meet November 11, 2023, 9:00 a.m. to discuss operations, 2024 budget increase, financial review, changes to White Goods Day. The public is welcome. Residents may drop off appliances weekly on Saturdays during regular business hours.

**Solar Panel and Solar Farm Ordinance:** research continues. NextEra Energy is still waiting for initial soil testing results before proceeding with meeting this fall/winter with residents. NextEra needs to secure an

additional 5% more land. At the last WTA meeting the following Wisconsin Solar Model Ordinance was reviewed <www.growsolar.org/wp-content/uploads/2020/09/WI-Solar-Ordinance-2020.pdf >.

**Solar Energy Permit Application**: Bear Creek Power has requested a permit application for the proposed 2624 Sherry-Sigel Road solar project.

**Utility Permit Application from InterCon Construction**: InterCon is doing the design work on Hetze and Brandl Roads for Alliant Energy. Supervisor Bean requests topic be tabled to the next meeting as project work will begin in 2024.
