Process Development - Administrative Charge Billing of Delinquent Sanitary Charges:

review of current list of six resident delinquent charges from Sanitary District. District sends delinquent Notice to resident and to the Town of amount due on Oct 1. Payment is due by Nov 1. If not paid 10% will be added if not paid by Nov 15. The charges, interest and special charges become a lien upon the parcel or estate. Copy of SS66.0809 mailed to District. Town will follow-up on parcels with delinquent charges on November 15 and forward to County Treasurers Office for charges to be added as a lien of parcel. No further action of Town needed until November 15.

City of Marshfield 2021 Unpaid Ambulance Invoice An invoice was sent to the estate of the deceased in September. No payment received from estate to reimburse the Town of Sherry for the City of Marshfield unpaid 2021 ambulance call.
