

**Town of Sherry
Regular Board Monthly Meeting Minutes
November 9, 2021**

The regular Town Board monthly meeting was called to order at 6:45 p.m. immediately after the Budget Hearing and Special Meeting of Electors. Chairman Homb, Supervisor Bean and Supervisor Holtz, Clerk Ewoldt, and Treasurer Haas were present.

Transfer Funds from Tax Savings to Checking: Not needed

Pay Bills: There was a motion to pay bills, by Supervisor Bean, second by Supervisor Holtz. **Motion carried.**

County Representative Report: No report

2022 Town Budget: There was a motion by Supervisor Holtz, second by Supervisor Bean to adopt the 2022 Town Budget by the major categories as printed. **Motion carried.**

Roads/Bridges:

Road Maintenance: Gravel roads have been graded except one road, which will be graded before winter. Road salt is available. The Plow Truck is ready to go. There was a discussion about culverts, driveways, and ditches.

2021 Road Work: The culvert patching on Hetze Road is completed. Two other patches still not completed. The culverts on Vruwink were completed.

Equipment Storage: Nothing new to report.

Broadband Services: Nothing new to report.

Agreements/Contracts: None received.

Resolution to adopt Wood County All Hazards Mitigation Plan: Tabled.

Correspondence and other updates:

- Governor Evers issued a proclamation declaring November 1, 2021, as Election Hero Day. The proclamation cited the unique and unprecedented challenges of the COVID-19 pandemic. The proclamation stated that our election heroes never fail to display courage, flexibility, resilience, and dedication to facilitating safe, secure, and successful elections, even in the face of a global pandemic that present additional risk and concern for health and safety. Clerk Ewoldt sent the Proclamation to the very deserving Town of Sherry Election Poll Workers and Cheri Dimick, former Town Clerk.
- Received a complaint November 4th. Someone was burning non-burnable materials, creating dioxin producing smoke.
- Trent Miner, Wood County Clerk, notified Municipal Clerks that the petitioners for the recall in the Stevens Point School District did not submit enough signatures for the recall process to move forward.
- Trent Miner, Wood County Clerk will provide Election Training for Municipal Clerks and Chief Election Inspectors on December 16th and December 18th at the Pittsville Community Center.
