

**Town of Sherry
Regular Board Monthly Meeting Minutes
February 9, 2021**

The regular Town Board monthly meeting was called to order at 7:00 p.m., with Chairman Homb, Supervisor Bean, Supervisor Holtz, Clerk Dimick and Treasurer Haas present.

The minutes from the January Town Board meeting were reviewed and approved with **a motion** by Supervisor Holtz, second by Supervisor Bean. **Motion carried.**

County Representative Report: No report

Recycling Center:

1. White Goods Days are set for May 15th, 2021 and September 11th, 2021. The committee is confirming the dates with Shaw's Wrecking Yard.
2. The Recycling Board is recommending Summer Hours on Wednesday evenings from 5:00 – 7:00 p.m., June 2nd to Sept 1st, 2021.
3. The Recycling center will be closed on Saturday, December 25th and will be open on Saturday, January 1st, 2022.
4. The invoice for gravel, fill and hours covered by a town of Sherry employee was clarified between the two towns.

Fairview Cemetery: There was one burial last month.

Roads/Bridges: Road Maintenance: Hahn bus garage complimented the town on the condition of the roads on the morning after the recent snowstorm. Sand applied to the roads helped the conditions. Supervisor Bean will check with Doug Vogel to place the old plow truck for sale online for a few weeks. Supervisor Bean will also check with Midstate Truck to possibly place it on consignment there if it does not sell online. Planning to evaluate the condition of the culverts on Hetze as roads thaw this spring to determine necessary future work. Planning to do some work on the brakes on the grader.

Spring Primary: Election will occur February 16th, 2021. There is one contest on the ballot: State Superintendent of Public Instruction.

Broadband Update: The tower is up in Arpin. An information meeting is planned for 2/20/21 and residents can sign up for the Bug Tussle service. Bug Tussle is looking for a tower location on Lonely road. There will a total of 18 towers in Wood County.

Transfer Funds from Tax Savings to Checking: **There was a motion** to transfer **\$300,000** from tax saving to checking by Supervisor Holtz, second by Supervisor Bean. **Motion carried.**

Pay Bills: **There was a motion to pay bills**, by Supervisor Bean, second by Supervisor Holtz. **Motion carried.**
