Town of Sherry Regular Board Monthly Meeting Minutes August 10, 2011

The regular Town Board monthly meeting was called to order at 7:00PM with Board, Clerk and Treasurer present.

The minutes from the July meeting were read and approved with a motion by Hetze, second by Mann. Motion carried.

The treasurer's report was read and approved with a motion by Mann, second by Hetze. Motion carried.

County Representative Report - no report.

A brief report was provided by Dave Homb based on his conversation with a representative from Kickapoo Valley Cheese Corporation. Kickapoo is planning a three phase expansion of their plant. Engineers are working on the design for Phase 1. Kickapoo purchased the Leonard and Kathy Brandl property. The existing house will be used for office space. Dave Homb offered the Town's support of the project. Town Hall Improvements - Sandy Lobner met with Bob Draxler, Electrician, just prior to the Board Meeting. He will provide a price proposal. Sandy has been in contact with Lynn Weigel, Plumber, to provide a plumbing price proposal. Coordination Plan Committee status report was provided by Sandy Lobner. The Committee needs volunteers to review chapters of the plan that are near completion. The volunteers will be asked to read, comment and offer editorial changes. Dick Lang from the Sherry-Blenker Sanitary District provided information on the collection and treatment system, along with a historical summary of the Sanitary District. Sandy also received information from Tom Hardinger regarding Bridges in the Town of Sherry. Kathy Termaat and Sandy have been working on editorial changes to the Plan. Next Committee meeting is scheduled for Aug. 30th beginning at 5 PM.

A discussion was held on Posting Sites and purchasing Enclosed Cases for Town Notices. The Clerk will do additional research on pricing, but was advised to go ahead with an order.

Discussion was held on current road work – work is progressing on the delivery of granite and road base. Chairman Homb asked Larry Pelot, Grader Operator to keep in contact with the Board as work is being planned and completed. Ed Hetze will be responsible for getting additional blades for the grader. Larry will keep Ed informed if additional blades are needed. Brush will be trimmed on Paradise, Hetze and Dairy Roads.

A motion was made by Hetze, second by Mann to pay bills. Motion carried.

Larry Pelot reports stumps on the east side of Norstrom Road.

Jim Mann reported that one of the street lights located in the park is not working.
