

Town of Sherry
Regular Board Monthly Meeting Minutes
July 9, 2013

THE REGULAR TOWN BOARD monthly meeting was called to order at 7:00 PM with Chairman Dave Homb, Supervisor Edwin Hetze, Sr., Supervisor Mann, Treasurer and Clerk present.

THE MINUTES FROM the June meeting were reviewed and approved with a motion by Supervisor Hetze, second by Chairman Homb. Motion carried.

THE TREASURER'S REPORT was reviewed and approved with a motion by Supervisor Mann, second by Supervisor Hetze. Motion carried.

COUNTY REPRESENTATIVE REPORT – Mr. Ashbeck reported Arpin – Vesper area – drilled holes for Frac Sand. Empty holes still open in fields. The County Board received a letter from Saratoga – requesting an Ordinance to block the factory farms.

ORDINANCE DESIGNATING ATV/UTV ROUTES AND REGULATING THE OPERATION OF ATV'S AND UTV'S – Ordinance #7-2013 was reviewed and discussed. The Ordinance was drafted using the Wisconsin Town Law Forms. A motion was made by Supervisor Mann , second by Hetze with an unanimous vote. The Ordinance will be in effect for one year, at which time the Town Board will review the effect of the Ordinance. The Ordinance will be posted on July 10, 2013. A Notice of the Ordinance will be published in the Marshfield News Herald on July 11, 2013. The Ordinance will be effective upon publication and posting.

OPERATOR/BARTENDER LICENSES: A motion was made by Jim Mann, second by Supervisor Ed Hetze to approve temporary Operator Licenses for the Sherry Tired Iron Classics Show to Roger Tomlinson and Mark Junemann. Motion carried.

FIRE DEPARTMENT CONTRACT: The current contract expires January 1, 2014. Town Board asked for audience input on new contract language. It was suggested that the Town Board request to meet with Fire Department at a Town Board Meeting. A letter will be sent to request that entire Fire Department Board and Officers attend the next Town Board Meeting.

CURRENT ROAD WORK:

Driveway on Herman Road – heavy rain washed over the road - 2.6 inches of rain. The Town may have to do more work to correct the problem. Culverts on Green Elm

Road – culverts need to be replaced. West Street – request to clean both sides of West St. ditch. Tenpas Road will add ½” road base. Bridge on Swedish Road – potholes near Herman Road – grind and add asphalt – coordinate with asphalt delivery for Dairy Road. Dairy Road – Mr. DeBoer will call American Asphalt to schedule.

MOTION TO PAY BILLS: A motion to pay bills was made by Supervisor Hetzewith a Second by Supervisor Mann . Motion carried.
