

**Town of Sherry
Regular Board Monthly Meeting Minutes
March 11, 2014**

The regular Town Board monthly meeting was called to order at 7:00 PM with Chairman Homb, Supervisor Hetze, Treasurer and Clerk present. Supervisor Mann was absent.

The minutes from the February meeting were reviewed and approved with a motion by Supervisor Hetze, second by Chairman Homb. Motion carried.

The treasurer's report was reviewed and approved with a motion by Chairman Homb, second by Supervisor Hetze. Motion carried.

County Representative Report – No report.

Employee Wage and Probationary Period: Survey conducted of area towns. Supervisor Mann was absent, so decision was tabled until next month. Supervisor Hetze made a motion to table until next month. Chairman Homb – second. Motion carried.

Elections: The **Spring Election** will be **April 1, 2014**. Absentee Ballots are available. Voters may obtain an Absentee Ballot by going to “MyVote.WI.gov”, or by contacting the Clerk. The signs for accessibility must be posted before the election.

Road Bids for 2014: Tabled until next month.

Bridge Meeting Report: Chairman Homb and Supervisor Hetze met with County Engineer to talk about installing culverts rather than replacing bridges. There is a 50/50 Bridge program. The Application is due by July 1, 2014 for next year's funding. Bridge inspections will be more in depth in this year. County Engineer will provide a report of the inspections to the Town. DNR permits are required for any culvert replacement. The County Engineer will do the permit applications for the Town.

Annual Town Meeting is set for Tuesday, April 15, 2014 at 8:00 P.M.

A motion to pay bills was made by Supervisor Hetze, second by Chairman Homb. **Motion carried.**

Correspondence and Other Updates:

- **Tables for the Town Hall** - The second shipment of tables was received. These tables were not damaged.
- **The Wood Co. WTA** meeting will be held Thursday, March 20, 2014, at the Richfield Town Hall. The guest speaker is Paul Zimmerman from the Wisconsin Farm Bureau.
- **The Department of Administration** will hold two Training Sessions for the Community Development Block Grant – Public Facilities and CDBG Planning programs. The sessions will be held April 9, 2014, and the second will be held April 23, 2014. The location information is forthcoming.
- **American Asphalt of Wisconsin** will hold asphalt paving information sessions. Two meetings will be held in our area. Weston – April 22 and Stevens Point April 24th. Registration is required by March 20th.
