Town Resident input:

1. Town residents attended a meeting with DNR officials and several community leaders on April 10, 2014, at Vesper. The meeting was a discussion of the concerns over phosphorus regulations, and the impact it will have on small communities to upgrade their wastewater treatment facilities to meet the stringent standards. Specifically, the concern raised is regarding the impact to the Blenker-Sherry Sanitary District's plant, and it's users. Dave Homb, Chairman, stated that he will arrange a meeting with the Town Chairman from Milladore and the Sanitary District Board. The Town of Sherry must be in the loop since the Town is the entity to apply for assistance when upgrades are required.
