**The regular Town Board** monthly meeting was called to order 7:00 p.m., with Chairman Homb, Supervisor Bean and Supervisor Hetze, Clerk Ewoldt, Deputy Clerk Dimick and Treasurer Haas present.

**Provider Agreement with Wood County For WisVote Services:** The WisVote Services agreement is for preelection services the County Clerk's Office provides, such as entering contests, candidates, ballot styles, etc. They also provide post-election services such as updating elected officials and county canvass information. **There was a motion** by Supervisor Bean, second by Supervisor Hetze to approve the agreement between the Town of Sherry and Wood County for WisVote Services as outlined in the Agreement. **Motion carried.** 

**Adoption of General Records Schedule:** The Wisconsin Historical Society revised the 1981 Records and Retention schedule. By adopting the General Records Schedule, the Town Board agrees to use the new records management guidelines. This also includes a disposition of records schedule. This will eliminate the requirement of having to notify the State Historical Society before disposing of records if the Town is following the schedule. The process to adopt the new General Records Schedule is to "Opt-In" to adopt the entire schedule, by notifying the Wisconsin Historical Society of the Town's intent to adopt the schedule with Form PRB-002. After the State Archivist approves the Notification of Adoption, the Town will adopt an Ordinance. **There was a motion** by Supervisor Bean, second by Supervisor Hetze, to notify the State Historical Society that the Town will adopt the entire schedule. **Motion carried**.
