## Town of Sherry Regular Board Monthly Meeting Minutes April 16, 2019

**The regular Town Board** monthly meeting was called to order 5:30 p.m., with Chairman Homb, Supervisor Bean and Supervisor Holtz, Clerk Dimick, and Treasurer Haas present.

**The minutes from** the March Town Board meeting were reviewed and approved with **a motion** by Supervisor Holtz, second by Supervisor Bean. **Motion carried**.

The treasurer's report was reviewed and approved with a motion by Supervisor Bean, Second by Supervisor Holtz. Motion carried.

**County Representative Report:** Bob reported the county is looking into concerns with the old buildings at the Southern Ohio Lumber Company that need to be removed from the flood plan and the FEMA funding could be lost. Chairman Homb will follow up with Jason Grueneberg from Planning and Zoning Office. County looking to set up a website to enhance economic development and towns can be involved.

**Recycling Center:** The Recycling Board met March 27th. The Annual Report of Accomplishments was submitted to the DNR. Former Clerk Ewoldt reported that several residents inquired about Summer Hours at the Recycling Center. They would like to see the Recycling Center open one evening during the week. Chairman Homb recommended a meeting with town of Milladore to discuss further.

Authorized Town Representative confirmed as Edwin Hetze and Rosie Ewoldt to continue as Clerk/Treasurer to the Recycling Board by a motion by Supervisor Bean, second by Supervisor Holtz. Motion Carried.

**Fairview Cemetery:** Authorized Town Representative **Edwin Hetze** by a motion by Supervisor Bean, second by Supervisor Holtz. Motion Carried.

Chairman Homb is working on a map of the lots.

## Land Acquisition:

Supervisor Bean discussed proposed land acquisition near the Cemetery, including 40 feet around the to allow for a road.

**Pioneer Bank – Board Resolution – Authorized Signatures**: The Town Board passed a Resolution Designating Public Depository and Authorizing Withdrawal for the Town of Sherry to change the current Resolution on file at Pioneer Bank to show Chairman Homb, Clerk Dimick and Deputy Clerk Ewoldt, in the absence of Clerk Dimick, and Treasurer Haas as authorized signatures, **by a motion** by Supervisor Bean, second by Supervisor Holtz, **Motion carried**.

**Deputy Clerk:** The Town Board confirmed the appointment of Rosie Ewoldt as Deputy Clerk, with a motion by Supervisor Holtz, Second by Supervisor Bean. Motion carried.

**Town Truck and Grader Storage:** Chairman Homb reported that Town of Milladore Chairman Hafenbredl contacted him to notify him that the Town of Milladore needs more room in their Town Garage, so they want to terminate the current agreement with the Town of Sherry by this fall. This will be brought back for further discussion.

**Road Maintenance/2019 Road Work:** Chairman Homb and Supervisors Bean and Holtz will tour the town roads Tuesday, April 23<sup>rd</sup>.
