Election News: The Spring Election was held on April 4, 2023 There were 488 voters on the poll list. There were 249 voters, casting 249 ballots, for a 51% turnout rate. There were seven election day registrations (new, different address or name change). The Sherry Board: Chairman, two Supervisors, Clerk and Treasurer were re-elected. There will be four Elections in 2024.

- Reviewed an anonymous concern raised to fill potholes on dirt roads.
