Regular Board of Supervisors Monthly Meeting Minutes
June 11, 2024

The regular Town Board monthly meeting was called to order at 7:00 p.m. followed by the Pledge of Allegiance. Chairman Lang, Supervisor Bean, Supervisor Holtz, Clerk Lobner and Treasurer Haas present.

Additions to the Agenda: None.

The minutes from the May 14, 2024, Town Board of Supervisors meeting minutes reviewed and approved by a **motion** by Supervisor Holtz, second by Supervisor Bean. **Motion carried.**

The treasurer's report was reviewed and approved with a **motion** by Supervisor Bean, second by Supervisor Holtz. **Motion carried.**

Pay Bills: Bill review completed followed by a **motion** by Supervisor Bean, second by Supervisor Holtz to pay all bills inclusive of Blenker Sherry Sanitary District delinquent charges. **Motion carried.**
