# Town of Sherry Regular Board of Supervisors Monthly Meeting Minutes June 13, 2023

**The regular Town Board** monthly meeting was called to order followed by the Pledge of Allegiance at 7:00 p.m. by Chairman Lang, Supervisor Bean, Supervisor Holtz, Clerk Lobner, and Treasurer Haas present.

Additions to the Agenda: County Road F Closure from Eight Corners to Blenker

**The minutes from** the May 9, 2023, May 23, 2023 and May 31, 2023, Town Board of Supervisors meetings were reviewed and approved with a **motion** by Supervisor Bean, second by Supervisor Holtz. **Motion carried**.

**The treasurer's report** was reviewed and approved with a **motion** by Supervisor Holtz, second by Supervisor Bean. **Motion carried**.

**Pay Bills:** Bill review completed followed by a **motion** to pay bills by Supervisor Bean, second by Supervisor Holtz. **Motion carried**. Clerk Lobner circulated the bills paid and payroll from last month for review by Chairman Lang and Supervisors Bean and Holtz.

Transfer Funds from Tax Savings to Checking: None needed.

County Representative Report: No report.

**Accounting Program** QuickBooks online subscription service cancelled. The migration back to QuickBooks Enterprise desktop version has a monthly subscription fee. The migration issues had their challenges.

**Mrozek / Dorshorst Fencing issue:** Chairman Lang sent letters to both parties following the June 7<sup>th</sup> final inspection. The fences are following state statutes. The Mrozek fence has a pending issue with two clips missing. Both fences should be monitored throughout the summer to maintain compliance.

The 'Protecting Municipal Right-of-Way' Program attended by Supervisor Bean on May 10<sup>th</sup> reporting that there will be significant placement of utility line, fiberoptics in Wood County, including the Town of Sherry. If not already done so, municipalities should be preparing to protect their municipal right-of-way. The Town of Sherry passed 2023 – 1 Utility Accommodation Ordinance on April 18, 2023.

**Utility Line Permit Modifications**: The permitting applications will be reviewed by Supervisor Bean and recommended modifications will be available at the next meeting.

2023 Assessment Roll process and reporting of Open Book and Board of Review is completed.

**Review Certified Survey Maps:** None. The Badger-land survey invoice for the Vermillion Street right-of-way was received and will be paid as approved earlier in the meeting.

**Rudolph River Rovers Snowmobile Club** represented by John Thomas and Ed Millville requested permission to use an area (approx. 300 ft) of Hetze Road just north of Sherry Sigel Road to access the trail. The snowmobile club will place trail route signage. The Club maintains >15 miles of trail. A **motion** to approve route by Supervisor Holtz, second by Supervisor Bean. **Motion carried.**
