

Town of Sherry
Regular Board Monthly Meeting Minutes
July 12, 2022

The regular Town Board monthly meeting was called to order at 7:00 p.m. Chairman Homb. Supervisor Bean and Supervisor Holtz, Clerk Ewoldt, Deputy Clerk Lobner and Treasurer Haas were present.

The minutes from the June Town Board meeting reviewed and approved with **a motion** by Supervisor Holtz, second by Supervisor Bean. **Motion carried.**

The treasurer's report was reviewed and approved with **a motion** by Supervisor Bean, Second by Supervisor Holtz. **Motion carried.**

Transfer Funds from Tax Savings to Checking: Not needed.

Pay Bills: There was a **motion to pay bills**, by Supervisor Holtz, second by Supervisor Bean. **Motion carried.**

County Representative: No report.

Recycling Center: Mr. Ashbeck contacted Rock Oil Refining to pick up used oil filters.

Fairview Cemetery: Supervisor Bean reported that he started staking the cemetery with one volunteer. Bev Peaslee, Rosie Ewoldt and Ashley Hollar volunteered to assist Supervisor Bean to complete staking the cemetery.

Authorized Signatures for Bank Accounts: There was **a motion** by Supervisor Holtz, second by Supervisor Bean, to add Sandra Lobner as an authorized signatory for Town of Sherry accounts at First State Bank. **Motion carried.**

Badger Book: It is recommended by Clerk Ewoldt that the purchase of Badger Book be deferred until the 2024 Budget.

Printer: The printer at the Town Hall is not working properly. It would cost more to fix it, if even possible, than to buy a new printer. The current printer at Clerk Ewoldt's home could be brought to the Town Hall. It was recommended by Chairman Homb to purchase a HP OfficeJet Pro 7740 Wide Format. Price check from several sources show a price of \$359.99. There was **a motion** by Supervisor Bean, seconded by Supervisor Holtz to purchase the printer recommended. **Motion carried.**

Road/Bridges – Road Maintenance:

- SolutionZ has completed most of the patching. South Bridge on Hetze Road needed repair. Wood County injected foam, but it will need riprap. Supervisor Bean will look at the site.
- Supervisor Bean will have SolutionZ look at and consider patching one of the Maple Road culverts.
- Chairman Homb okayed a request a group who will be moving school from Mayflower Road to Hetze Road.
- Granite will be applied to certain roads this week. Mr. deBoer said they would blade the roads after the application. Calcium chloride will be applied afterwards. One load should be sufficient.
- There is a Request for stop sign at Lonely Rd and Vruwink Road. There was **a motion** by Supervisor Bean, second by Supervisor Holtz to place a stop sign at the location request. **Motion carried.**

Purchase Land to Build a Storage Building; There was a **motion** by Chairman Homb, second by Supervisor Holtz, to purchase the land described in the Resolution from the Special Meeting of Electors. **Motion carried.**

Review Ordinance Relating to Placement of Cable and Culverts on Town Roads: No action

Nuisance Burning Ordinance: DNR states fire chief should be monitoring illegal burning.
