Regular Board Monthly Meeting Minutes
July 14, 2020

The regular Town Board monthly meeting was called to order at 7:00 p.m., by Chairman Homb with Supervisor Bean, Supervisor Holtz, Clerk Dimick and Treasurer Haas present.

The minutes from the June Town Board meeting were reviewed and approved with **a motion** by Supervisor Holtz, second by Supervisor Bean. **Motion carried.**

The treasurer's report was reviewed and approved with **a motion** by Supervisor Bean, Second by Supervisor Holtz. **Motion carried.**

County Representative Report: 2020 Central Wisconsin State Fair has been cancelled.

Recycling Center: Light bulbs, batteries and electronics have been picked up. Cost for these was about \$2000.00. This was 2 years' worth of bulbs and 1 year worth of batteries and electronics.

Fairview Cemetery: Cemetery committee met on Wednesday, July 8th; included Ron Lobner, Bev Peasley, Rosie Ewoldt and Supervisor Jeff Bean. Discussed cemetery operations and compared to other cemeteries around the area. Additional members are welcome to this committee and can contact Jeff Bean for more information.

Roads/Bridges:

Road Maintenance: Paving and shouldering of Lang and Partner is complete. Invoice included the bridge paving on Partner and Arpin-Sherry Roads. Gravel on Rose is done. Rock rake worked well on the gravel roads. Will try using it on road base roads. Crack sealing is complete. One load of dust proofing was applied to town roads. Will apply more after Rose is complete.

Storage Building: Nothing new to report.

Broadband Update: Chairman Homb is meeting with Mary Lippert and people from other towns regarding grant opportunities.

Transfer Funds from Tax Savings to Checking: **There was a motion** to transfer **\$100,000** from tax saving to checking by Supervisor Holtz, second by Supervisor Bean. **Motion carried.**

Pay Bills: **There was a motion to pay bills except for** the payment to Town of Milladore for Recycling labor, by Supervisor Bean, second by Supervisor Holtz. **Motion carried.** Clerk Dimick will request additional information from the Town of Milladore regarding the dates that Town of Milladore covered labor for Town of Sherry and bring back to the next board meeting for review.
