

**Town of Sherry
Regular Board Monthly Meeting Minutes
August 9, 2021**

The regular Town Board monthly meeting was called to order at 7:00 p.m., with Chairman Homb, Supervisor Bean and Supervisor Holtz, Clerk Ewoldt, and Treasurer Haas present.

The minutes from the July Town Board meeting were reviewed and approved with **a motion** by Supervisor Holtz , second by Supervisor Bean . **Motion carried.**

The treasurer's report was reviewed and approved with **a motion** by Supervisor Bean, Second by Supervisor Holtz . **Motion carried.**

County Representative Report: No report

Recycling Center: **There was a motion** by Supervisor Holtz, second by Supervisor Bean to confirm the appointment of Sarah Hughes to fill in when other recycling employees are unable to work their regular shift. **Motion carried.** The Recycling Board will meet on Saturday, August 14th to complete and file the application for grant funds for 2022, along with other agenda items.

Fairview Cemetery: Nothing new to report.

Sherry Tired Iron Tractor Club Event: The Tractor Club is seeking approval to extend the walkway from the current walkway leading from the park shelter to the back entrance of the Town Hall. There was **a motion** by Supervisor Holtz, second by Supervisor Bean to approve the walkway extension. **Motion carried.**

American Rescue Plan Act Funds: The Wisconsin Towns Association provided a sample Loss Revenue calculation. They are working with the Department of Revenue to provide additional information. Clerk Ewoldt suggested the American Rescue Plan Act Funds received in the amount of \$41,605.75, be transferred to the Town Savings Account. **Motion:** There was a motion by Supervisor Bean, second by Supervisor Holtz to transfer the ARPA grant funds to the savings. **Motion carried.**

Roads/Bridges:

Road Maintenance: Discussion about Maple Road bridge. Inspection report does not show major problem. No further action at this time. Road signs have been replaced on Hetze and Swedish Roads. Tiger Board signs are installed on all bridges, including the Maple Road bridge.

2021 Road Work: Supervisor Bean will follow-up on Granite delivery.

Equipment Storage: Nothing new to report. Wait until building costs come down.

Broadband Services: Chairman Homb reported the grant has been submitted.

Resolution to adopt Wood County All Hazards Mitigation Plan: Sarah Christensen from Wood County Emergency Management will be at the Wood County Unit of WTA on August 20, 2021. This would be a good opportunity to ask questions about the All Hazards Mitigation Plan.

Transfer Funds from Tax Savings to Checking: Not needed

Pay Bills: **There was a motion to pay bills**, by Supervisor Bean, second by Holtz . **Motion carried.** Clerk Ewoldt will get a confirmation of Maple Road Bridge inspection charges.
