# Town of Sherry Regular Board of Supervisors Monthly Meeting Minutes September 12, 2023

**The regular Town Board** monthly meeting was called to order followed by the Pledge of Allegiance at 7:00 p.m. by Chairman Lang, Supervisor Bean, Supervisor Holtz, Clerk Lobner, and Treasurer Haas present.

Additions to the Agenda: .gov Emails, Shed Insurance.

**The minutes from** the August 8, 2023, Town Board of Supervisors meeting was reviewed and approved with minor corrections by a **motion** by Supervisor Holtz, second by Supervisor Bean. **Motion carried**.

**The treasurer's report** was reviewed and approved with a **motion** by Supervisor Bean, second by Supervisor Holtz. **Motion carried**.

**Pay Bills:** Bill review completed followed by a **motion** to pay bills by Supervisor Bean, second by Supervisor Holtz. **Motion carried**.

**Transfer Funds from Tax Savings to Checking:** A **motion** by Supervisor Holtz, second by Supervisor Bean to transfer \$45,859.00 from the reserve ARPA Savings to Checking Account for expenses associated with the storage shed payment #2. **Motion carried.** A **motion** by Supervisor Holtz, second by Supervisor Bean to transfer \$26,000.00 from savings account to checking for monthly expenses. **Motion carried.** The Town previously received \$83,212 earmarked for ARPA spending. After the transfer of the \$45,859.00 there will be a remaining balance of \$0 funds available.

County Representative Report: No report.

**Bug Tussell Wireless Permit Application**: application sent to Bug Tussell in March. Currently no application is filed, nor fee payment.

Certified Survey Maps: None.

**Town Hall Update:** A **motion** by Supervisor Holtz to proceed with installation of LED interior lighting, seconded by Supervisor Bean. **Motion** carried. Clerk Lobner provided estimates for consideration of pressure washing exterior vinyl siding, interior town hall painting, replacement of ceiling tiles, replacement of a few nesting banquet tables, replacement of four folding chairs. The request is for an item or two to be completed each year. In CY2023 13 town hall rentals with income totaling \$1350. Town Hall cleaning deposit refunds are \$750 thus far. Additional Town Hall rentals and refunds can be anticipated during the remaining CY2023.

**Open Records Request Election Items and Wood County GIS**: records request received by Wood County town municipal offices.

**Contract for Cooper Winter Propane**: A **motion** by Supervisor Bean, second by Supervisor Holtz to not sign the contract. **Motion carried**.

#### **Storage Shed Update**

- Supervisor Bean reports construction continues. Earlier in this meeting ARPA funds were obligated to project expenses.
- A motion by Supervisor Bean, second by Supervisor Holtz for Clerk to contact Rural Insurance to add the storage shed to current policy. Motion carried.

### Roads / Bridges and Road Maintenance:

- Bliven Lane more research is needed
- Road grading will begin after the next rain.
- P-71-938 Green Elm Road Bridge Inspection Report reviewed and is unchanged from 2022.
- Road assessments will be completed on September 27, 2023, 9:00 a.m. A notice will be published.

Fairview Cemetery: Supervisor Bean reports lot staking for two monuments; and no lot sales.

**Recycling Center Update:** Supervisor Holtz reports good turnout on White Goods Recycling Day. A brat fry was held the same day. The Recycling Board met on August 26, 2023, to discuss operations, 2024 budget, financial review, changes to White Goods Day, additional staff needed on September 9, 2023, 8:00 a.m. – 1:00 p.m. as well. The 2024 budget will be similar or a slight increase.

**Solar Panel and Solar Farm Ordinance:** research continues. NextEra Energy is still waiting on initial soil testing results before proceeding with meeting this Fall with residents.

### Additions to Agenda:

The .gov emails for the town board, clerk and treasurer will need to transition to a new host site as contract with the State of Wisconsin's vendor will not be renewed by the State. Research on options continues.
