Town of Sherry Regular Board Monthly Meeting Minutes July 11, 2017

The regular Town Board monthly meeting was called to order at 7:00 p.m., with Chairman Homb, Supervisors Hetze and Bean, Clerk Ewoldt and Treasurer Haas present.

The minutes from the June meeting were reviewed and approved with **a motion** by Supervisor Hetze, second by Supervisor Bean. **Motion carried**.

The treasurer's report was reviewed and approved with a motion by Supervisor Bean, second by Supervisor Hetze. Motion carried.

County Representative Report: Mr. Ashbeck reported on wild parsnip in the eastern part of the county. The plant may resemble dill weed, but the sap is very dangerous. It can cause blisters. If it is found, residents should report to Wood County Land & Water Conseration Department at 715-421-8475. Eron Agronomics is authorized to spray for noxious or invasive weeds along the roads. Wood County won't cut the weeds because it spreads the seeds. Other invasive species found in our area are buck thorn and phragmite (tall reed like plant), which was reported near the Tower in the Town of Milladore.

Recycling Center: A meeting will be scheduled between the Town of Milladore and the Town of Sherry. The new employees at the Recycling Center are doing great. The gates have been painted red.

Coordination Land Use Plan – 5 Year Review:

Copies of the plan were given to the Board Members for their review of the Goals, Objectives and Policies, specifically in Sections 1, 9, 10, 11 and 12. They will make their recommendations for any changes at the next meeting. The Advisory Committee meeting will be postponed until a later date.

Cemetery: The Wood County Emergency Management Department's Community Service Program representatives, Steven Kreuser and Mark Stinkney met with Roger Ewoldt at the Fairview Cemetery today. The work crew will be at the cemetery to straighten headstones starting July 13th. They estimate 3-4 days of work. The town will furnish road base and black dirt.

Roads/Bridges: Swedish Road culverts – Chairman Homb contacted Scott at Jewell Associates, for his recommendations to correct the problem. The Board will contact the Contractor to discuss correcting the problem.

Road Maintenance: The Grader is in the shop. Chairman Homb will mark potholes for patching, and contact A-1 Services.

Town Hall – Air Conditioning: Rapids Sheet Metal will install the air conditioner on the north wall of the town hall within the next week.

Transfer Funds from Tax Savings to Checking: Not needed at this meeting.

Pay Bills: There was a motion to pay bills, by Supervisor Bean, second by Supervisor Hetze. **Motion carried**.

Public Input:

There was a complaint about mud on the road. Discussion followed.
